- 4) Vendor space must be paid for in advance.

- 5) No one will be allowed to participate as a vendor without a signed agreement.
- 6) No used items or clothing allowed.
- 7) Products or services cannot be changed after agreement is signed.
- 8) No food is allowed to be cooked and sold inside or outside the building.
- 9) No alcoholic beverages of any kind may be sold inside or outside the building.
- 10) **Do not tape, tack, nail or hang anything to any of the building walls.** Signs may be displayed on top of the table or taped to the table.
- 11) Items and/or information must be neatly arranged on the table.
- 12) Vendors selling clothing on hangars must provide own clothing rack. Due to space restrictions the rack must not be longer than 5 ft in length and must be displayed behind the table. The rack cannot be placed beyond the length of the table or block the view of other vendors.
- 13) Vendors will not be allowed to bring an extra table.
- 14) Set up & break down will begin 20 minutes before the beginning & ending of each event.
- 15) Vendor must provide on table no greater than 6 feet in length.
